IMPORTANCE OF STANDARDIZED ADDRESSES

An address criteria:

- It Must Be Complete A building number, street name, community, postal district, postal code & country.
- It must be correct the content must accurate for receipt of mail.

- IT MUST BE UNIQUE each address must identify ONE location (address).
- A person needs an address to be recognized as an individual, as a citizen, or a consumer.
- Addresses are an essential tool for economic and social development.

- •Without them, individuals cannot be reached, businesses cannot be identified by potential clients, and public services cannot be properly delivered.
- •Modernization- implementation of the Universal Postal Union (UPU's) international standard of addressing; S-42


POSTAL CODE IMPLEMENTATION PROJECT

S-42 is a universally accepted addressing format that breaks down an address into its basic elements and thus enables standardization and consistency; nationally and internationally.

- A 6-digit, all-numeric sequence;
- Postal code implementation has been completed and there are postal codes available for the entire country;
- Residents are officially informed of respective postal codes through the completion of the address improvement project.








ADDRESS IMPROVEMENT PROJECT

- Collaboration with the city/ borough/ regional corporations and the Tobago House of Assembly.
- Task force & field officers; collect data & renumbered buildings that are improperly numbered, or not assigned numbers.

- Streets without street signs were identified and reported to the municipal authorities.
- Unnamed streets were identified and reported to the municipal authorities.



The S-42 standard improves the quality of addresses and discontinues the uses of:

- Lamp post numbers
- Mile markers
- Corner of
- Street name without building numbers
- Lot numbers

ADDRESS IMPROVEMENT PROJECT METHODOLOGY

- Buildings are numbered sequentially.
- Even numbers are on one side and odd numbers on the other side of the street.
- Building numbers are assigned to vacant lots (for future development).

- Building numbers are assigned based on lot sizes, approximately 5000 sq. Ft.
- Postcodes are assigned to all addresses.
- Address cards with new postal addresses for every delivery point will be distributed.

- Correcting addresses does **not** impact the following:
 - Deeds or lot numbers;
 - Building plans.

- The corrected address represents a Postal Address alone.
- It does not change who resides there or occupies the premises.
- It does not change your identity.
- It identifies a location to foster improved communication and delivery of goods and services.

BENEFITS TO CITIZENS AND COUNTRY

• The postal services: improves the efficiency and accuracy of locating addresses and thereby improves mail delivery.

- For the private sector: improved product delivery and location of addresses, which would allow businesses to effectively locate and reach their customers. Promotion of e-commerce.
- •For the public service: improved billing and customer service.

- Planners; National spatial development initiative will be enhanced.
- It will assist in traffic management, disaster management and emergency response
- •It will help citizens to better locate addresses; friends and relations who moved from one place to another.

CHALLENGES

- Full adoption of the addresses encourage public to update the address;.
- •Unnamed streets will not receive cards.
- Persons not at home during the execution of the data capturing exercise can bring in the cards and we will reprint with full names.
- Delivery of not at home would have (Mr./Mrs./Miss) on the card.

These property classifications will not receive cards but will have assigned numbers:

- Vacant Lots,
- Abandoned,
- *Under Construction and
- Optional (property on the corner).
