EXPRESSION OF INTEREST (EOI) REQUEST FOR EXPRESSIONS OF INTEREST FOR AN INTERNATIONAL OPERATOR/ INVESTOR/PURCHASER FOR THE MAGDALENA GRAND BEACH AND GOLF RESORT, TOBAGO

Evolving TecKnologies and Enterprise Development Company Limited (e TecK) hereby invites the submission of an Expression of Interest (EOI) from suitably qualified Investors/Operators/Purchasers with the financial capability and a proven track record who can provide a structure that would allow for renovations, repositioning/branding and a plan to improve the performance of the Magdalena Grand Beach and Golf Resort, Tobago ("the Services"). Investors/Operators/Purchasers must indicate interest in the following options:

- Option 1 Internationally Branded Operator brand operator of international renown who would also operate the hotel, or a third party hotel management operator with the brand being franchised.
- Option 2 Investor for the Property strategic partner who will provide the capital investment and bring the necessary management and branding expertise. This option may entail the partner acquiring partial or majority ownership of the hotel via divestment.
- Option 3 Outright purchase of the Hotel Asset.

A combination of Options can also be explored.

The Magdalena Grand Beach and Golf Resort is located at the Tobago Plantations Estate in Lowlands, Tobago. The hotel was initially opened as the Tobago Hilton Golf and Spa Resort in 2000 and was closed in 2008. In 2011, the property was upgraded and it was officially reopened as the Magdalena Grand Beach and Golf Resort. It is located on the southern side of the island close to the Atlantic Ocean. The Resort consists of 178 guest rooms and 22 parlours and offers a wide array of amenities and activities on site. There are numerous dining options, an 18-hole golf course, functional spaces and other amenities for guests to enjoy.

The hotel is a 15 minute drive from the international airport. Guests can access the island via various international flights and 20 minute domestic flights from Port of Spain. The Port of Scarborough is also a 12 minute drive from the Property.



Prospective entities may associate to enhance their qualifications, but must indicate in the EOI whether their association is in the form of a Joint venture, Consortium or other proposed structure.

Interested entities must provide the following information as a minimum:

- 1. Company Profile: Name, Country of incorporation, address of the corporate headquarters and its branch office(s), date of incorporation and/or commencement of operations.
- 2. Brief description of the Company including details of its main lines of business and proposed role and responsibilities, including website URL and brochures for reference, as well as profile of management staff, stating qualifications.
- 3. Details of individual(s) who will serve as the point of contact within the company for communication with e TecK: Name, designation, address, power of attorney from the Applicant, telephone number, email address, fax.
- 4. Description of similar type projects undertaken or owned by the entity.
- 5. A proposed structure that would allow for renovations, repositioning/branding and a plan to improve the hotel's performance.

- 7. Provide evidence of financial capacity to fund such project.
