

Tender for the Replacement of the Double Layer Asphalt Membrane Roof System at the Sangster's Hill Mall, Tobago

The project involves the removal and replacement of approximately 1,100 square meters of the Double Layer Asphalt Membrane Roof System at the Sangster's Hill Mall. The scope of works includes but is not limited to the following:

- Remove existing cap flashings over parapet walls
- Clean and prepare both concrete slabs, parapet walls, eastern sidewall of roof access room and remove all residue to ensure smooth surface to receive membrane
- Supply and install fixing agent (primer) to both concrete slabs and parapet walls for application of membrane
- Supply and install fixing agent (primer) to outer perimeter sidewalls of roof access room for application of membrane
- Supply and install double layer asphaltic membrane to concrete slabs and parapet walls
- Supply and install double layer asphaltic membrane to outer perimeter sidewalls of roof access room
- Supply and install 26ga PVF224 in Parapet Cap Flashings
- Repaint border around top of building after parapet installation to match existing
- o colour
