Request for Proposal for an Investor, Operator or Purchaser of the Magdalena Grand Beach and Golf Resort, Tobago

- Option 1 Brand Operator of international renown who would also operate the hotel at the Magdalena Grand Beach & Golf Resort, or a third party Hotel Management Operator with the brand being franchised; OR
- Option 2 Strategic partner who will provide capital investment and bring the necessary management and branding expertise to the Magdalena Grand Beach & Golf Resort, which may entail the partner acquiring partial, majority or full ownership of the hotel via divestment; OR
- Option 3 Purchase of the Magdalena Grand Beach & Golf Resort hotel asset.

The Magdalena Grand Beach and Golf Resort is located at the Tobago Plantations Estate in Lowlands, Tobago. The hotel was initially opened as the Tobago Hilton Golf and Spa Resort in 2000. In 2011, the property was upgraded and reopened as the Magdalena Grand Beach and Golf Resort. It is located on the southern side of the island close to the Atlantic Ocean. The Resort consists of 178 guest rooms and 22 parlours and offers a wide array of amenities and activities on site. There are numerous dining options, functional spaces and other amenities for guests to enjoy. The hotel is a 15-minute drive from the international airport. Guests can access the island via various international flights and 20-minute domestic flights from Port of Spain. The Port of Scarborough is also a 12-minute drive from the Property.

Tendering will be conducted through the Single Envelope Competitive Bidding process in accordance with e TecK's procurement guidelines.
